The Adopt-A-Family Program

The EBCAP Adopt A Family Program finds the goodwill of the community in the form of sponsors who provide gifts for families. The lean budgets of the families we see often don't stretch far enough for holiday gift-giving. The holidays can be a time of anxiety rather than celebration. Low-income families within the East Bay area nominated by case managers are eligible to participate. Many of EBCAP's client families live at 200% of poverty or below.

Together we help families as they celebrate the holidays.

The Adopt-A-Family program matches client families in need of holiday gift assistance to sponsors who anonymously provide gifts for them.

You can sponsor one person, one family, or multiple families depending on how much you want to give. Families of all sizes and ages need support.

BY NOVEMBER 10

 You may request family size, type, and ages – we will make every effort to match your requests. Early registration ensures the best match!

BY NOVEMBER 14

 Registered sponsors notified of the family match and given a suggestion gift/shopping list.

DONATIONS AFTER NOVEMBER 30

Financial donors may continue to donate checks or provide gift cards (in \$25 increments) so that families who were not able to participate in the "sponsor matched" portion of the program can still be supported (limited depending on availability).

Register

- Registration is open in October until all clients are matched with a sponsor (usually mid-November).
- You may request family size and ages we will make every effort to match your requests. Early registration ensures the best match!
- You will be notified in early November about the individual or family you've been matched with.

Family Match

You will receive an email from adoptafamily@ebcap.org or be mailed with your family gift suggestion list. Please confirm receipt with an email back to us so we know you received it. We do this sponsor confirmation to ensure every family is matched, so we must hear back from you to confirm.

Confidentiality

 Families seeking support live in our community; they may be families you know from school, church, sports, and activities. As they seek support we ask that you honor our confidentiality promise: that all forms of assistance provided will be held confidential, both in our building as well as when out in the community.



About Your Family Gift Wish List

- Your list may have several choices of items listed per person. Choose from among the
 items on the list. The list of options does not mean you should purchase all the items
 on the list! These are simply here to give you options.
- Each wish list is different. We try to honor each family's wishes as they present them to us. Some lists can be very detailed; others can be simple and limited to practical needs. Our case managers encourage families to specify multiple gift ideas and capture as much information about size, color, and style to help you as a sponsor.

Shop...Shop...Shop!

- Have fun shopping!
- Use your best judgment if your gift list is less detailed.
- Gifts for children 12 years and under are preferred over gift cards.



Getting Gifts Ready for Drop Off...Please Remember to:

- Do not wrap gifts, if you would like to provide the family with gift wrap please bag it and label it with family#.
- Label each gift with the Family# and Child# of the recipient.
- Highlight gifts purchased on the suggestion/wish list, so families will know which items were purchased and give the list to staff when dropping off.
- Put gifts in large bags. Label each bag with family number and number of bags (1 of 3, 2 of 3, 3 of 3), and close bag to ensure that gifts cannot fall out.
- Please place gift cards in separate envelopes labeled with the Family# and Child# of the recipient. Then place all envelopes into a bag or a large envelope marked with the Family# to ensure they do not get lost. Please give the staff at the site any gift cards.
- Keep the donor receipt form for your tax records if you'd like to.
- Deliver gifts to the location you chose in Newport or Riverside on TUESDAY, DECEMBER 13th—9:00
 AM-3:00 PM
 - -Groups must deliver gifts at one time.
 - —Drop off gifts only at the specified hours (when we have personnel and volunteers checking in gifts).
 - —Early drop-off is discouraged due to space and security concerns.
 - —Late drop-off IS NOT POSSIBLE because families and individuals come to pick up their gifts on Wednesday, December 15th.

So no one gets left without a gift by mistake!

- Your itemized list is a great help to us to ensure that every person on our list matches every person on your list. With hundreds and, hundreds of gifts being delivered in just a single day, your gift itemization and labeling are so important and appreciated.
- Please highlight gifts purchased on the list and place it INSIDE your large plastic bag containing the gifts.
- List the Family # of the gift recipient and Child# that is in each package. For example, EP#21 Child #1
